Introduction

Welcome to the "The World I Imagine" Global Youth Art Contest — an international, youth-led initiative celebrating creativity, belonging, and hope.

This contest invites **refugee**, **immigrant**, **and global youth** to envision a more inclusive and peaceful world through art. Whether you paint, draw, or create collages, your artwork can help others see *the world you imagine* — one where everyone belongs.

1. Contest Theme

"The World I Imagine."

Through your art, show us your vision of a future filled with compassion, unity, and hope. You may explore any of the following ideas:

- Belonging finding home, identity, or community in new places
 - Make an artwork that shows what it means to find home, feel accepted, or be part of a community.
- Resilience overcoming challenges and adapting with strength
 - Make an artwork that shows how people stay strong, face challenges, and keep going.
- **Hope** envisioning a peaceful, inclusive, and creative world
 - Make an artwork that shows your vision of a kind, peaceful, and inclusive world.

Each artwork should connect personally to "The World I Imagine" while expressing your own story and perspective.

2. About the Contest

The *World I Imagine* Art Contest is organized by **Tulip's Promise**, a non-profit organization supporting refugee and immigrant youth through creativity, cultural exchange, and educational empowerment.

This contest provides a platform for young voices worldwide to express hope and reimagine belonging through visual storytelling.

3. Contest Advisors

The contest is guided by a group of experienced mentors and educators committed to uplifting refugee and immigrant youth through art:

4. Eligibility

The contest is open to young artists worldwide who meet the following criteria:

• Age Range: 11–19 years old

• Divisions:

Junior Division: Ages 11–14Senior Division: Ages 15–19

• Eligibility:

- Open to all youth globally, with a focus on refugee and immigrant participants
- Only one artwork per participant may be submitted
- o There is no entry fee

Group entries are not allowed; each submission must be an individual's original work.

5. Art Categories

Participants may submit **one artwork** in one of the following categories:

- 1. **Drawing / Painting** Make an artwork using things like watercolor, acrylic, markers, pencils, or ink.
- 2. **Collage** Make an artwork by cutting, layering, or combining materials like paper, photos, or fabric.

All artwork must be original and created solely by the artist.

6. Submission Requirements

Submission Deadline: March 31, 2026

All entries must be submitted **online** through [https://forms.gle/QUykmk7BLMLGJCFGA].

Required Materials:

- 1. Artwork Image
 - JPEG or PNG format, high-quality, max 10MB
- 2. Artist Statement (50-200 words)
 - What inspired your piece?
 - o How does it reflect "The World I Imagine"?
- 3. Artist Information
 - o Full name, age, division (junior or senior), country, and contact email
- 4. Parent/Guardian Consent (for participants under 18)
 - A signed form or checkbox confirming consent

Incomplete submissions or late entries may not be considered.

7. Judging Criteria

Criteria

Each artwork will be evaluated by a diverse panel of **artists**, **educators**, **and community leaders**, including the three contest advisors.

Description

Judges will assess each piece based on the following criteria (scored 1–5):

Creativity & Originality	Uniqueness of idea and visual expression
Emotional Impact	Ability to move, inspire, or connect emotionally
Technical Skill	Proficiency in the chosen medium
Relevance to Theme	Clear connection to "The World I Imagine"
Artist Statement	Reflection and clarity of message

Judges' decisions are final.

8. Awards & Recognition

Winners will be selected for each age division (Junior and Senior).

Grand Prize Winner (1 per Division)

- \$200 Prize (cash, visa, etc.)
- Certificate of Achievement
- Featured in online exhibition

Second Place Winner (1 per Division)

- \$150 Prize (cash, visa, etc.)
- Certificate of Achievement
- Artwork featured in the online exhibition

Third Place Winner (1 per Division)

- \$100 Prize
- Certificate of Achievement
- Artwork featured in the online exhibition

Honorable Mentions (5 total)

- \$25 Prize
- Certificate of Achievement
- Artwork featured in the online exhibition

All Participants

- Digital Certificate of Recognition
- Artwork included in the online exhibition

All finalists will be honored in the official online exhibition and recognized through our digital platforms.

9. Digital Exhibition

A global digital exhibition of finalist artworks will launch in June, 2026.

Select artworks may also be included in a **community showcase** or **museum partnership exhibition** during **June 2026 (World Refugee Day)**.

10. Code of Conduct

By submitting artwork, participants agree to the following terms:

All entries must be original and created solely by the artist.

- Al-generated, copied, or plagiarized works are not accepted.
- By submitting, artists grant Tulip's Promise permission to display their credited work online or in exhibitions.
- Artists retain full copyright and ownership of their work.
